TERMS AND CONDITIONS

- 1. The validity of the certificate expires six (6) months from the date of full payment or upon full importation of the declared quantity before the stated duration.
- 2. Validity of the certificate covers products from the supplier and country of origin stated above. This certificate cannot be used to cover other suppliers of the same product.
- 3. This form shall only be used for products from the same supplier and country of origin. Use a separate copy for a different country of origin.
- 4. Application for renewal of the certificate must be done at least 30 days before the expiry date or exhaustion of quantities, whichever comes earlier.
- 5. The Agency shall conduct random inspections to ensure conformity to stipulated standards.
- 6. FALSE or MISLEADING INFORMATION will result in the rejection of the application.
- 7. The Agency shall withdraw the certificate issued to an importer on the following grounds:
 - a) If upon random sampling of a product covered by the certificate and imported by the holder is found to be nonconforming to the standards declared under the Act;
 - b) If the importer contravenes any provisions of the Act.
